Both first place awards went to our First Street Speakers contestants! Victoria McQuarrie won the International event with her speech, "Jury Duty" - a funny yet unifying topic that left the audience hopeful and smiling. Alyson King won the Evaluation event with her thoughtful and personal comments. Her Toastmasters experience gave her an edge in standing out among the contestants. Vaibhav reminded me to summarize my feedback at the closing which is one of the speech judging criteria in the contest. I've always felt a challenge to balance my feedback so that it is encouraging more than offering improvement points and I will likely continue to struggle with that somewhat. But taking it to a competitive level helps me hone the skill of empathy which makes me a better listener and evaluator.

It was my first contest and it gave me a chance to see how differently people from other clubs speak, their different styles and ways of doing things. Outside club exposure gives you a view of different approaches.
